## **CALL TO ORDER:**

### **DISCUSSION:**

- General Maintenance – Maintenance of garages and parking lots during the break.

## **UF-608 PARKING GARAGE XIV – DESIGN PHASE DEVELOPMENT**

**PRESENTING: STUART CULLEN, PD&C**

### **DISCUSSION:**

Stuart Cullen present the design phase development for Garage XIV to be located at the north end of the commuter lot on Gale Lemerand Drive. The scope of the structure is now 632,000 square feet, with 2,030 estimated space capacity. The presentation and discussion included the following:

- Northbound and south bound bus areas
  - ✓ New lanes on Gale Lemerand Drive
  - ✓ Bus pull out redesign
- Pedestrian traffic – Raised crosswalks.
- Traffic calming
- Archer Road reconfiguration
- Bike area
- Exterior elevations – Projected look of garage from different angles.

Construction is to begin at start of 2019 with completion early 2020. It was asked how early in 2020 the projected date of completion would be. Completion is set for January.

## **ACTION:**

There was a motion set to approve the design development as presented and Sandra TenBroek moved to approved, seconded by Scott Washburn. The motion passed.

## **UAA 41 BASEBALL STADIUM**

**PRESENTING: MILES ALBERTSON, PROJECT MANAGER, CONSULTANT TO PD&C**

### **DISCUSSION:**

Miles Albertson announced that this project's transportation element will return to the committee in February and this was an advisory. The project will be presented to Land Use Committee for utilities. Presentation and discussion points will include;

- Traffic Study
- Parking projections - unchanged
- Entrance and egress from the facility
- Multiple events – Softball games, museums, Philips Center

Linda Dixon added that the project building and parking are considered an altogether one design.

### **DISCUSSION:**

Additional items were presented for discussion by the committee:

- Lighted "No Turn on RED" sign – Inquiry will be done with the City of Gainesville.
- Sandra TenBroek talked about parking concerns at Animal Science. Enrollment has increased. Straughn Center events continue to displace parking. Ron Fuller and Scott Fox stated that parking has been opened on Shealy Drive and Richey Road.
- Bruce Welt inquired about electric vehicle charging stations, use by students and length of time permitted to keep a vehicle at a charging station. Charging stations may be used by everyone (general public, students, faculty and staff). There is a 4 hour time limit at these stations. It is enforced.
  - ✓ Suggestion was preapproval to use charging stations
  - ✓ User counts – data and numbers
- Parking and Transportation Study
- Bike parking in the new garage (Garage XIV)
